Sub: Issue of certificates for disposal of conversion applications by GA&PG Deptt.

GA and PG Deptt. after careful examination have been pleased to approve the rationalisation of assessment of conversion fee in respect of land leased out by GA&PG Deptt. for residential purpose vide order No. 19899 dtd. 13.06.2025.

The said order provides that the applicant at the time of filing application for freehold is required to file a certificate issued by the competent authority of BMC/BDA regarding building construction without any plan deviation /deviation within the permissible limit/compounding of plan deviation.

For new conversion application as well as for pending conversion applications, it was decided to obtain certificate from BMC for disposal of the conversion cases. A clarification to that effect was issued vide Order No. 20373 dtd. 18.06.2025.

To expedite the issue of the relevant certificate and disposal of the conversion applications, the matter was reviewed by the Chief Secretary.

After careful examination, the following orders have been passed to expedite disposal of conversion cases:

a) Considering the expertise and manpower available with BDA, it has been decided to issue the relevant certificate by BDA in place of BMC.

- b) The applicants (Both Pending & New) are required to apply before the Planning Member, BDA enclosing the relevant documents in the format enclosed herewith at Annexure-I.
- c) The Planning Member, BDA after verification of necessary documents and field is required to issue certificate in appropriate cases in the format enclosed herewith at Annexure-II.
- d) The certificate shall be issued within 15 days from the date of filing of application by the applicant.
